

Parking Policy 2011 – 2012



1. Students driving to school may only park their vehicle in the student parking lot.
2. Student parking on school days (6:00 AM to 3:00 PM) is allowed by school approved parking permits
3. Students must park in a designated area, **[Between white lines]**
4. **Students must register their vehicle(s) with the school administration (Bookstore) by:**
 - a. Providing proof of valid Arizona Drivers license and,
 - b. Proof of current Arizona vehicle registration and,
 - c. Proof of current auto insurance.
5. Students will pay a fee of \$50.00 per year to park in the student lot. **STUDENT PARKING PERMITS ARE NOT TRANSFERABLE**
6. Students must have a 2011 - 2012 parking sticker on vehicle they are driving. Students must register each car they may be driving to school. (Family cars)
7. Students must display sticker on inside of front windshield, lower corner, drivers' side, with permit number visible through glass.
9. Students should not leave personal or school property in vehicles.
10. Students must obey all traffic laws and school rules to include but not limited to:
 - a. speed limit (5 miles per hour, mph)
 - b. control and/or use of vehicle
 - c. directions of school employees
 - d. no passengers in the back of an open truck bed
 - e. parking in assigned spaces only
11. Students should not loiter in parking lot; or near cars.
12. Students should not illegally park vehicles.
13. After School hours: Students shall not access parking lot without written permission from security or administration.
14. Students shall not access vehicles without written permission from security or administration.
15. Students shall not move vehicles once parked, until departing from school.
16. Student vehicles may be searched if reasonable suspicion warrants.
17. Students must cooperate with authorities if access to vehicle is requested.
18. Students will obtain a new sticker if previous sticker was lost or stolen.

19. Students will lock (secure) vehicle at all times. All students park at their own risk. Higley Unified School District is not responsible for any theft, vandalism, or damage to any vehicle.
 20. Parent/Guardian and student will sign and complete parking permit form prior to being issued a parking sticker.
 21. Violations will be reported to the School Security and the Administration Staff. Repeat violators may lose their parking permit; have a fine issued, have their car towed, and/or be subject to school discipline.
 22. Students will pay for towing and storage if a vehicle is towed as a result of Administrative or Law Enforcement actions.
