Children need healthy meals to learn. **HUSD** offers healthy meals every school day. Breakfast costs \$2.10; lunch costs E-\$3.00, M-\$3.40, H-\$3.55. Your children may qualify for free meals or for reduced-price meals. Reduced-price is \$0.00 for breakfast and \$0.00 for lunch due to a State-Approved Subsidy. This packet includes a school meal application for free or reduced-price meal benefits and application directions.

WHO IS ELIGIBLE FOR FREE MEALS? All children in households receiving benefits from **SNAP**, **FDPIR** or **TANF** can get free meals regardless of your income. Foster children that are under the legal responsibility of a foster care agency or court are eligible for free meals.
